### **EXCLUSIVE REMEDY**

Your Nystrom product is warranted to be free from defects in manufacturing, materials, factory finishes and workmanship. This Limited Warranty is made as of the date of product purchase and is not a warranty of future performance.

If a covered defect is reported within **FIVE (5)** years from the date your Nystrom product was originally shipped, and otherwise in accordance with the terms of the Limited Warranty, Nystrom will, at its option, repair or replace the product or component, or refund the price paid for the defective product or component. Removal, installation, finishing, refinishing, and disposal costs and services are not included. Replacement parts or products are also warranted but are subject to the original product's warranty notice period.

### EXCLUSIONS

Damages, defects, or problems resulting from causes outside Nystrom control are excluded from coverage under this Limited Warranty. Such causes include, without limitation:

- Products that have been subjected to misuse, abuse, modification, neglect, or improper handling, storage or use.
- Defects and damages resulting from improper product installation or from failure to follow Nystrom installation instructions and guidelines.
- · Impact of foreign objects, extreme weather events, or any act of God.

- Corrosion due to salt spray or exposure to coastal conditions (5-mile proximity to coastal conditions).
- Costs associated with normal wear and tear, natural weathering of surfaces, and/or fastening hardware.
- Any damages resulting from any other cause not involving manufacturing defects.
- Any damages or poor product performance resulting from installation into a condition that exceeds product design standards and/or certified performance standards and/or certified performance specifications and/or is not in compliance with building codes.
- Failure to use product in methods consistent with Nystrom product manuals.
